




SPECIFICATION

The Department of Transport invites quotations from reputable Service Providers for Supply and Delivery of Ante Mortem Blood Alcohol Kit.

- 1. Blood alcohol collection kit is used to take a sample of blood from an individual, whether they are suspected of a crime, or they need to be tested for intoxication.
 - Blood alcohol collection system is used for blood samples that are needed for laboratory testing and the after the traffic officer can know the percentage of alcohol from the suspected drunken driver.
- 2. The kit must have.
 - Evacuated glass tube with specially formulated butyl rubber stopper. Controlled draw provides proper sample volume for intended procedure.
 - Double pointed blood collection needles for multiple samples multiple sample needles have a self-sealing shut off value on the butt end.
 - Polypropylene needle holders with guideline for prepositioning of tubes.

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.









2. **DEFINITIONS**

- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).




