



The Qualifications Council for Trade & Occupations governs all Trade Testing in South Africa under the National Artisan & Moderation body and in line with the Trade Test Regulations published in 2014. Therefore, a Service Provider is required for the ARPL of 23 Artisan learners (17 x Electrical: Construction and 6 x Auto Electrical) within the Community Based Programme for a period of 2 days.

The Service Provider requirements are as follows:

- The ARPL for electricians i.e., construction (CETA) and auto (MerSETA) is required for 23 Community Based Programme's Artisan learners from across the Eastern Cape Province.
- The 23 Artisan learners should be assessed at the QCTO and NAMB accredited Trade Test Centres within the Eastern Cape for the skills i.e., Electrical (17 x electrical construction and 6 x auto electrical) for a period of 2 days.
- Service Providers must identify learner skills gaps to establish a set of data for intervention.
- Service Providers must make valuable recommendations on further learning to be undertaken by the learners based on the ARPL outcomes within 30 days after the initial assessment.
- Service Providers must make sure learners are registered on the relevant ETQA/SETA database for the ARPL Trade Test.
