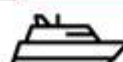
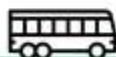

2.	<p>The Quality Council for Trades and Occupations (QCTO) has become the primary body responsible for the accreditation, implementation, assessment, and certification of occupational qualifications, part qualifications, and skills programmes from June 2023.</p> <p>1. What will happen to companies that respond to the bid whose accreditation is valid during the submission but is ending in mid-2023?</p> <p>2. The occupational skills are being phased out; how will the department handle this change as the QCTO accreditation process is long?</p> <p>3. The occupational skills may be changed or fused; how will the department move forward?</p>	<p>1. The SDPs must adhere to the current SETA accreditation legislation and follow further instructions from the relevant SETAs on the QCTO accreditation process. Proof of SDPs' accreditation status by the QCTO will be verified by the department.</p> <p>2. The QCTO stated that a teach-out period will allow learners who enrolled before 30 June 2024 to continue their studies until 30 June 2027, however, result statements and certificates will no longer be provided after 30 June 2027.</p> <p>3. The QCTO and SETAs will communicate any changes in occupational skills to all relevant stakeholders.</p>
