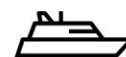
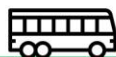

- The bidder must make sure that the employees report on duty for the daily checks on time as per the Airport operating hours or at request by Airport management.
- The electrician will be required to be on a standby in case of emergency (e.g. Power-cut or when requirement arise, but will be informed on time)
- Employees will be required to undergo the security check with SAPS before they are issued with a permit to work at the airport.

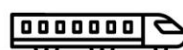
