1.	Legacy Qualifications: Legacy qualifications in South Africa will end on 30 June 2024, causing a significant adaptation in the skills development landscape. All learners must be registered for occupationally directed qualifications through the QCTO from 1 July 2024. Bidders are strictly prohibited from registering learners for qualifications that are not aligned with the Occupational Qualifications Sub-Framework (OQSF). What measures is	Despite the bid being initiated in the second quarter of 2023, the procurement process was plagued by serious internal challenges that affected its conclusion. As a result, the document still bears the legacy skills. It is expected that SDPs have applied for accreditation of the new programmes with the QCTO thus proof of registration with the QCTO must be submitted with this bid to make the process of matching skills easier after the appointment. DoT will continue to work closely with the relevant SETAs, the QCTO and



	the department taking to ensure compliance with this regulation?	to identify unit standard-based programmes to meet the requirements of accredited skills programs on the OQSF. In cases where there is not a direct match, DoT will take charge and drive the collaboration to ensure the creation of customised programmes that are tailored to its needs. By doing so, we will ensure that our skills development programmes are always relevant, up-to-date, and effective in meeting our objectives.
2.	Training Facility: What will the role of the DoT be in the assessment of the training facility?	DoT and its stakeholders will conduct due diligence to confirm compliance during the bid evaluation process. Facilities must meet all the requirements of the trade or discipline as per the bid. SDPs must ensure that the training facilities/workshops are suitable (whether leased/owned/have an MoU). Suitable training facilities are critical for developing skilled and innovative personnel. Vocational participants and technical employees in CBP must undergo both theoretical and practical training. Therefore, SDPs must always consider the minimum requirements.
