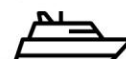
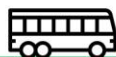

Service providers is required for the relocation of two bulk filers from the Pic n Pay Building (Bisho) to the Erf 5000 Building (Bisho). 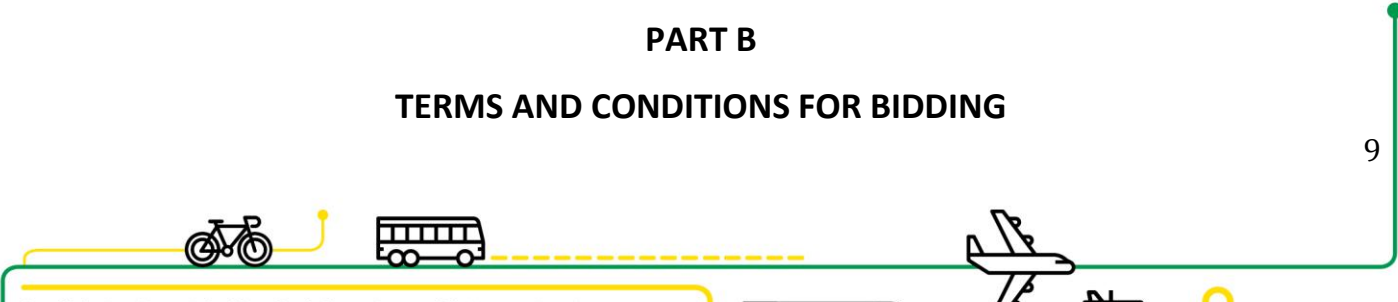
