Service providers is required for the relocation of two bulk filers from the Pic n Pay Building (Bisho) to the Erf 5000 Building (Bisho). The purpose of the briefing is to allow the service provider to assess both the current location and the new site, ensuring that they are familiar with the space and all requirements for the dismantling, movement, and reassembly of the filters. This includes evaluating building access, floor space, and any structural considerations, ensuring that the filers can be safely and efficiently moved without causing damage.

The briefing will also provide an opportunity for the service provider to review the new building layout and floor capacity to ensure proper reinstallation. A site visit is essential to identify any obstacles, plan for the proper disassembly and reassembly, and assess any special requirements or risks involved in the relocation process. This step is crucial for a smooth and safe transition of the bulk filers to their new location.
