 - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
 - (b) any other invitation for tender, that either the 80/20 or 90/10 preference point system will apply and that the lowest acceptable tender will be used to determine the applicable preference point system,

then the organ of state must indicate the points allocated for specific goals for both the 90/10 and 80/20 preference point system.

FORMULAE FOR CALCULATION POINTS

To Score points for Equity Ownership / Disability/ Locality the following formula will be used to calculate the points out of 5 points Max.

$$SGP = \frac{\%OE \ (CIPC \ / \ from \ BBBEE)}{100} \ X \ MEO(Max = 4)$$

(e.g) Women Equity Ownership $=\frac{89}{100}X4=3,56$

Where

SGP= Specific goals points

OE = Ownership Equity

MOE= Maximum points for Equity Ownership
