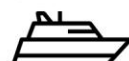

QUOTATION EVALUATION CRITERIA

Stage 1 - Compliance

Please note bidders who do not comply with the following requirements will not be moving to the second stage.

Tenderers must take note of the following:

- Bidders are required to be registered with Centralized Suppliers Database [CSD] with Treasury prior to submit this quote.
- The tender will be evaluated according to the preferential procurement model in the preferential Procurement Policy Framework Act (PPPFA 5 of 2000): Preferential Procurement Regulations, 2022 as well as the SCM Policy of the Department of Transport.
- The following Declarations must be completed: **SDB 1, SBD 3.1, Bid Pricing Form, SBD 4, SBD 6.1, and SBD 7.2 (Part 1 Only)** forms **MUST** be fully completed and submitted with the quotation.
- Bidders must be legal entity or partnership (consortium);
- Bidders must provide supporting documentation as per the Quotation specification schedule requirement.
- Bidders who are not registered for VAT are not eligible to claim VAT in their pricing.
- Bidders should take note that price is not a determining factor to award the Quotation.
- Bidders Particulars form **MUST** be fully completed by Bidders.
- **Pricing Schedule MUST be fully completed failure to do so will render the bidder non-responsive.**

Furthermore, quotation offers will only be accepted if:

SPECIFICATION FOR A SERVICE PROVIDER

DESCRIPTION: HIRING OF SMALL PLANT FOR STRUCTURAL WORKS IN R72 – HAMBURG PROJECT

Type of Service Required: Hiring of Small Plant for Structural Works (2-Wheel Driven Diesel Concrete Mixer (400l), Concrete Cutter Diesel 500 Mm, Diesel Vibrating Jumping Jack Hammer).

Work included in the Specifications: The work included in this specification consists of the delivery to site, hiring and use and removal from site of small plant as listed in the schedule of quantities /Pricing schedule. It also includes the supply of fuel for all small plants listed in the pricing schedule and 30 cutting discs.

Compliance with Specification & Statutory Regulations: All specified small plant to be offered by the Service Provider must be in good condition and must comply in all respects with the requirements of the Factories, Machinery and Building Work Act 22 of 1941 (as amended).

Quantities: According to quantities indicated in the schedule below

Site/Terrain: On the R72 - HAMBURG PROJECT

Contract Duration: 04 Months from date of receiving award letter and purchase order.

Rate: The **Rate** must include all **fuel costs** for the duration of the contract as per the pricing schedule.

Daily Rate: Where the schedule provides for the hire of plant on a daily basis rate (Rand/day) the following shall apply.

Where the Schedule of Rates require a rate in terms of Rand/Day then the **working hours per day shall not exceed 9 (nine) hours for normal working days (07 to 17h00).**

Normal working days are from Monday to Friday inclusive. Saturday and Sunday and Statutory Public Holidays of the Republic of South Africa are not regarded as working days and payment shall not be made for Plant which is not working on those days. Where plant does work on these days payment shall be made proportionally to the maximum of 9 hour day – i.e. {(Number of hours actually worked / 9) x Rate}.

Schedule of Rates: **The Schedule of Rates shall be completed in such a way that, ALL columns shall be completed, failure to complete the pricing schedule as required will invalidate the Bid.**

The above rates shall include (where applicable) for:-

- The cost of hiring the plant
- The cost of the experienced operator
- The cost of the fuel and lubricants where “wet rates” apply.
- All ground engaging tools (where applicable).
- All overhead and administrative costs associated with the hire of the Small Plant.
- Establishment and de establishment Costs
- Contractor’s profit.
- **Inclusive of 15 % VAT**

Transport Distances: Transport to and from site/terrain must be include in the daily rates.

Notification:

The procedure which will be followed during normal working hours, when plant is required to be hired will be as follows:-

- The Contractor will be given an Official Purchase Order before commencement of the contract. The contractor will be advised by email that a particular Plant is required, the date when it will be required, the name of the person who is in charge of the site, the period for which it will be required.
 - The Contractor has a **maximum of five (5) working days after receiving a purchase order to deliver**. Failure to communicate with the Department within the specified period **will be deemed non-responsive and will result in cancellation on the contract.**
 - **The Service Provider must not supply without any official purchase order;**
 - No payment will be made for any plant other than that specified in the Official Order Form.
 - Upon the failure of the Contractor to deliver the Plant that he stated would be available on the agreed date, the Employer may give written notice that, unless the required item is delivered to site within 24 hours of the issue of such a notice, alternative arrangements shall be made by the Engineer and all cost incurred, including the cost of the difference in the hire rates, could be born by the Contractor who so defaults.

Hiring Times:

Once the plant is delivered to the Site, the Contractors' representative shall sign the Plant Log Sheets at the end of each day and shall hand them to the official in Charge of the site. A signed copy of the Hire Log Sheets duly signed by the Official in Charge of the Site, will be handed to the Contractors representative at the end of each week.

Breakdown:

Whenever the small plant is unable to work because of breakdowns, for whatever reason these breakdowns occur, the number of actual hours worked will be logged and the small plant shall be off hire for that duration and payment shall be made proportionally to a maximum 9-hour day – i.e. {(Number of hours actually worked/9) X Rate}.

Logbook and Time Sheets:

The Department will issue the contractor with a Departmental logbook when the plant is delivered to site. Daily Time Sheets from the logbook must be submitted with the monthly invoices or else no payment will be processed.

Invoicing:

Each invoice shall refer to the Official Purchase Order Number and shall have attached thereto copies of the Hired Log Sheet and Departmental Daily Returns signed by the Contractor's representative and the Official in Charge of the Site.

Operators:

Where the operator is required to be provided with an item of plant, he/she shall be experienced in the use and operation of such plant. The Operations of Plant shall comply at all times with the requirements of the Factories, Machinery and Building Work Act.

Security:

The Contractor shall allow within the rates for parking, guarding and general security of the Plant after working hours. The time taken to travel to and from such secure area as the Contractor may choose shall not be for the Employer's account.

Validity Period:

60 days from date of closing.

Services Level Agreement:

The successful bidder will be required to sign a Services Level Agreement with the Department.
