

The purpose of the expression of interest is to compile a register of responsive respondents to participate in a framework agreement and to submit their credentials, so they may, in terms of the Employer's procurement procedures, be invited to submit work package quotation offers should they qualify or be selected to do so for provincial surfaced road reseal and/or rehabilitation related scope of work within the Eastern Cape Province on an "as and when required" basis over a period of 3 years. Responsive respondents will be invited to submit quotations based on their CIDB grading thresholds.

Framework agreements do not impose financial obligations or any quantum of work within the framework agreement term on the Employer.
