- Professional Nursing Service to draw blood from suspected drunken drivers arrested by Law Enforcement Officials. (Traffic Officers and Police Officers)
- According to the occupational Health and Safety Act (85 of 1993), it is legal obligation to ensure that safety and health at all times are adhered to.
- Road Maintenance in in compliance with the Act to ensure that periodic examinations which includes clinical examinations, biological monitoring by an occupational health practitioner.
- The service is to ensure that we always keep road users in check
- The objective of the service is to adhere with all statutory regulations at all times ensuring that drivers are complying with the road regulations
- The occupational Health practitioner will assist to render the service as a specialized service governed by legislation

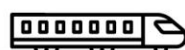
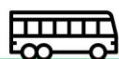

- All professional nurses appointed to render service at any given time must bring their own personal protective equipment like surgical gloves, masks etc
