A. EVALUATION CRITERIA

STAGE 1 - COMPLIANCE

Please note bidders who do not comply with the following requirements will not be moving to the second stage. Tenderers must take particular note of the following:

- Bidders are required to be registered with Centralized Suppliers Database [CSD] with Treasury prior to submit this quote.
- The tender will be evaluated according to the preferential procurement model in the preferential Procurement Policy Framework Act (PPPFA 5 of 2000): Preferential Procurement Regulations, 2022 as well as the SCM Policy of the Department of Transport.

A. PROJECT SPECIFICATION

DESCRIPTION: RENTAL OF CAMP YARDS FOR COFFEE BAY TO ZITHULELE PROJECT FOR A PERIOD OF NINE (9) MONTHS

Type of service required:

The Department of Transport requires the services of Rental of Camp Yards from suitable service providers for Coffee Bay to Zithulele Construction Site for a period of NINE (9) MONTHS.

Camps to be rented:

Camps to be rented detailed as follows with each camp's purpose:

1. Camp 1 _ Residential camp for employees and a part of it is used for machinery park area and as a materials & equipment store area = R10 450.00
2. Camp 2 _ Construction Site office and Workshop area = R10 450.00
3. Camp 3 _ Machinery Park area (used for plant on site along the area under construction) = R8 000.00
4. Camp 4 _ Aggregate storage area, storm-water drainage materials and machinery (material hauled from Zithulele quarry) = R 3600
5. Camp 5 _ Machinery and material storage camp for Phase 3 activities = R3 600. 00
6. Camp 6_ Machinery Park area and aggregate storage = R 6 000

NB: rates stipulated above are rates from land owners.

Security Measures:

Security for the camps is the Client's responsibility and the department (IHC) has already deployed guards on the above-mentioned stations/camps.

Maintenance of Camps:

It is the Client's responsibility as there has been an agreement with the land owner on that matter.

Quantities:

According to quantities indicated in the pricing schedule on page.

Validity Period:

60 days from date of closing

Rental payment:

The rental amount as stipulated in the Schedule of Quantities must be paid on the 1st of each month for each landlord for the duration of this contract. **Delays in receiving payment from the Department will not be accepted as an excuse for not paying monthly rentals.**

Proof of Payment: A deposit slip should reflect the name of the Camp Owner and the amount paid.

Invoices:

All invoices should be accompanied by proof of payment, confirmed by site manager and emailed to **InhouseConstruction.invoices@ectransport.gov.za**. Each invoice shall refer to the official order number.

Schedule of Rates:

The Schedule of Rates shall be completed in such a way, that the entire column shall be completed. Failure to complete the schedule as required will invalidate the bid.

The above rates shall include (where applicable) for all overhead and administrative costs associated with the services rendered and the contractor's profit.

Notification

The Service Provider must not render services before receiving an official order

No payment will be made for any services other than that specified in the Official Order Form.

Lease Agreement:

The Service Provider must enter into a lease agreement with the/a landlord. Where the Service Provider is the rightful owner of the property he/she must provide such a lease to the Department.

Lease agreements must specifically include that under no circumstances should the camps be locked for the employees to not access the resource due to unpaid rent issues.

The Department has a right to terminate the contract at any stage when there is no necessity for those services anymore.
