SPECIFICATION FOR A SERVICE PROVIDER

A. PROJECT SPECIFICATION

DESCRIPTION: PROVISION RENTAL OF ACCOMMODATION FOR SITE PERONNEL IN COFIMVABA-ASKEATON ROAD FOR A PERIOD OF SEVEN (07) MONTHS

Type of service required:

The Department of Transport requires the services of Rental accommodation of **35 Officials at Intsika Yethu Local Municipality** from suitable service providers for a period of **7 MONTHS**. **Accommodation to be rented should be inclusive of electricity:**

1 Security features:

All doors and windows must be secured and must be in good condition. The yard must be fenced with lockable gates so as to secure vehicle that would be parked within the premises. The premises without a yard must have a 24-hour security service.

2 Maintenance:

The yard must be cleaned, and grass must also be cut on a monthly basis. The supplier will be given two (2) days to fix any defects, such as changing of light bulbs, painting, carpentry and plumbing where necessary.

3 Services:

Municipal rates will be the service providers responsibility and should be paid monthly, meaning there should be enough electricity every month for each person/room as these rates will be included on the monthly rental rate.

Maintenance:

It is the Client's responsibility as there has been an agreement with the land owner on that matter.

Quantities:

According to quantities indicated in the pricing schedule on page.

Validity Period:

60 days from date of closing

Rental payment:

The rental amount as stipulated in the Schedule of Quantities must be paid on the 1st of each month for each person for the duration of this contract. **Delays in receiving payment from the Department will not be accepted as an excuse for not paying monthly rentals.**

Proof of Payment: A deposit slip should reflect the name of the Land Owner and the amount paid.

Invoices:

The Schedule of Rates shall be completed in such a way, that the entire column shall be completed. Failure to complete the schedule as required will invalidate the bid.

The above rates shall include (where applicable) for all overhead and administrative costs associated with the services rendered and the contractor's profit.

Notification

Lease Agreement:

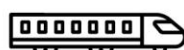

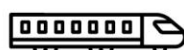

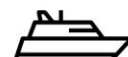
